Takeovers Panel Rules in Favour of Finders

Target Price: A\$0.36

The Takeovers Panel has declined to conduct proceedings and declared that there was no reasonable prospect it would make a declaration of unacceptable circumstances. The allegations made by Eastern Fields Developments Limited (EFDL) were not sustained. It is our view that the bid of 23¢/sh gross undervalues the company versus our valuation of 36¢/sh.

Takeovers Panel Considerations

- Independent directors believe MQ'18 guidance to indicate copper production of 4.1-6.8kt (Petra 5.8kt), the implication being; guidance is unchanged.
- Independent directors maintain their belief that in JQ'18 nameplate production of 28ktpa will be achieved and then maintained through CY'18.
- The independent expert, upon reviewing actual production data from Jan/Feb and utilising a more conservative recovery profile, declared that there was no material impact to its valuation.
- The independent expert did not alter its opinion that the offer is neither fair nor reasonable.

Our View and Valuation

- We are surprised by the success of the negative campaign run by EFDL. As a low cost, 28ktpa copper producing asset, Finders' Wetar Copper Project is a very material and appealing asset. If EFDL did not already have a blocking stake we would have expected several rival bidders to have emerged.
- Our valuation of 36¢/sh is based on 1xNPV¹² of the current reserves, with significant upside in the event of further discoveries.
- The company generated strong EBITDA of US\$72m in CY'17 and has repaid US\$93.5m debt since 30-Jun-16, net project debt was US\$51.5m at 31-Dec-17.

Catalysts

- Production – MQ'18 production results should show significant improvements as the operation recovers from a crusher failure and crud run event in late CY'17.
- Exploration – Exploration on the tenement package could commence as early as Apr-18 which would highlight the excellent brownfield exploration potential at prospects like Meron.
- Dividends – We expect the remaining debt of US\$51.5m to be fully repaid throughout CY'18 and allow Finders to commence repatriating cash and paying a dividend.

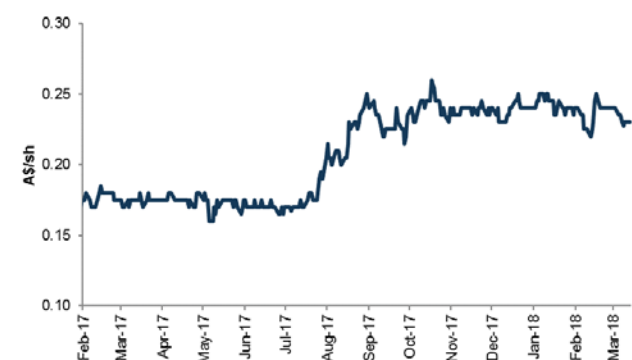

Strong free cash flow and closure of the hedge book has allowed the company to pay down US\$93.5m of debt since 30th Jun 2016, net project debt was reduced to US\$51.5m at 31-Dec-17.

In late 2017 the project experienced unexpected operational difficulties in the form of a crud run through event and a crusher breakdown. We believe this was the catalyst for its Indonesian partners to form EFDL and on 6th Oct 2017 launch an opportunistic takeover bid at 23¢/sh, which in our view grossly undervalues the company versus our target price of 36¢/sh. On 15th February the takeover bid was declared unconditional and allows EFDL to acquire share on market at the 23¢/sh bid price.

If the bid is unsuccessful we expect the company to generate strong free cash flow of A\$92m in CY'18, be in a net cash position in 2H'18 and repatriate cash to shareholders.
